Meetings, Finances and the Capital Campaign

ur annual meeting on Saturday, April 6, 2002, was attended by 16 alumni, 16 undergraduate members and 12 pledges. Robert Rumler '36 was the oldest attending alumnus. He said the enthusiasm shown by the alumni and undergraduate members was encouraging, and he felt better about the future of the house than he did after his last visit several years ago.

Arthur Keen '68, Roy Prescott '58 and Eric Bengston '75 were elected to the board of directors. Immediately after the annual meeting, the board elected the following officers: Arthur Keen '68, president; Roy Prescott '58, vice president; Eric Bengston '75, treasurer; and Matt Espenshade '95, secretary.

Financial statements for the fiscal year ending August 31, 2001, for the Alpha Zeta Corporation and the Alpha Zeta Charitable Trust can be found in this newsletter. As a result of the capital campaign, public support in the form of contributions has increased substantially. Most of the costs of the capital campaign are behind us and will be reduced in the current fiscal year. The decline in the assets of the charitable trust was caused by the decline in the stock market.

Our capital campaign, "Preserving the Past ... Ensuring the Future," has not reached its goal of \$600,000. We are now at about \$560,000 pledged. Of 99 class agents, 37 have not made a pledge to the campaign. I have to

assume that if you have not made a pledge, you have not made your phone calls. Fund-raising statistics show that many class agents do not make the phone calls they have agreed to make. Let's prove the statistics wrong. Please make your pledge and your phone calls. If for any reason you cannot make your phone calls, please contact me. We hope to get started on the renovations during the summer of 2003.

Dr. John Cairns Initiated After 60 Years As Pledge

GIVES THE TERM "ETERNAL PLEDGE" NEW MEANING

Ending what is probably the longest pledge period in the history of the fraternity, John Cairns Jr. was initiated into Alpha Zeta on March 13, 2002, during a special ceremony in Blacksburg, Va. Several members of the Morrill Chapter, in conjunction with the Alpha Zeta chapter of Virginia Tech, officially welcomed our newest brother to the organization.

"Sixty years ago I hoped to become a member of Alpha Zeta," said Cairns in a recent letter. "Now, at 78, I finally made it!"

Dr. Cairns' story is quite unusual. In the early 1940s, while beginning his undergraduate studies in biochemistry at Penn State University, Cairns completed the pledge program at AZ. However, before he could be initiated as a brother, he left school to serve his country during World War II. Upon his return home, Cairns married his fianceé, Jean, who was also majoring in biochemistry at Penn State. However, at that time, there was no housing available for married couples. Cairns left Penn State and finished his undergraduate studies at Swarthmore College in 1947.

After Swarthmore, Cairns went on to earn an MS and Ph.D. from the University of Pennsylvania, which led to a long and distinguished career in the field of environmental biology. His list of

honors and accomplishments is quite extensive. He has served as vice president and president of the American Microscopical Society, served on 18 national research councils (two as chairman) and is currently serving on 14 editorial boards. In addition, Cairns has authored 56 books. With over 1,400 publications to his credit, he has achieved a level of expertise that few of us will ever reach. In November 2001, Cairns received the Sustained Achievement Award from The Renewable Natural Resources Foundation. His most recent project, Goals and Conditions for a Sustainable World, is available to be read free of charge online at www.esep.de/journals/esep/esepbooks.html.

Currently, Cairns is a professor emeritus at Virginia Tech. He and his wife reside in Blacksburg, Va.

The Morrill Chapter learned of Dr. Cairns' story during the capital fund-raising campaign. Art Keen, president of the corporation board of directors, contacted Cairns about being a class agent. Cairns mentioned that, technically, he was not a true member of Alpha Zeta since he was never initiated. At the next meeting, president Keen brought the matter to the attention of the corporation board. It was the decision of the board to finish what had been started — to make Cairns an official member.

"Dr. Cairns' exemplary career should be an inspiration to us all," said president Keen. "The fact that he has supported AZ financially and emotionally, while not a member, is extraordinary."

Contacts were made with the Virginia Chapter of AZ at Virginia Tech through Charlene Shupp, a former chancellor and Virginia Chapter alumnus. The leaders of Virginia Chapter were more than willing to host the event, and soon the wheels were put in motion for our trip to Blacksburg.

Three undergraduate members of the Morrill Chapter volunteered to represent the fraternity at the initiation. Michael Flinchbaugh '02, John Stinavage '03 and Jessica Worobey '04 traveled from State College and, after meeting up with Charlene Shupp and me, traveled on to Blacksburg.

Everyone arrived at the Virginia Tech campus around midnight on Tuesday, March 12. The next morning, the undergraduates and alumni met with John White '65, the associate dean of agriculture at Virginia Tech and an alumnus of the Morrill Chapter. Dean White has been a strong supporter of Virginia Tech's Alpha Zeta chapter throughout the years. He met with the group for about an hour, sharing experiences and

talking about the changes he has seen at the university. Before leaving the meeting, the undergraduates presented Dean White with a coffee mug that was made in honor of the Morrill Chapter's centennial celebration.

The rest of the morning was spent touring campus, taking in the various sights of the bustling university. The mix of military and civilian students on campus was quite different from the atmosphere in State College. While meeting with the Virginia Chapter's chancellor, Sue Rosoff, for lunch, we finalized plans for the initiation ceremony. Several members of the Virginia Chapter volunteered to fill in the positions needed to make the ritual complete.

Before the ceremony, there was a mixer for the members of the Morrill and Virginia chapters. It was a time to get to know fellow Alpha Zetans and to share stories of how Alpha Zeta has influenced our lives. Jess Worobey said, "It's amazing to think you can be connected to people you've never met, with hundreds of miles between you, with just those two powerful letters — AZ."

For the initiation, the Virginia Chapter reserved a large meeting room in Squires Student Center. Each chapter had a display showing its history and current AZ activities.

The initiation ceremony had a great impact on all who attended. Personally, I've seen the initiation ceremony performed several times, but none have been more beautifully orchestrated as the one performed that night.

Cairns arrived and was greeted by several members of the Virginia Chapter. As an extra touch, the new initiate was given a pledge pin to wear during the ceremony. At the conclusion, Mike Flinchbaugh removed the pin from Cairn's lapel and replaced it with a new AZ pin.

Following the ceremony, a reception was held in Cairns' honor. He spoke about how much the night meant to him. While at Penn State, he met his wife, Jean, Through the years, they have shared many experiences. Now in their latter years, Jean has developed Alzheimer's and Parkinson's diseases. Today, much of brother Cairns' time is dedicated to his work and to her. One element of Jean's condition centers on her difficulty remembering recent events, but she can recall things from her past. When Cairns informed her that he was going to be initiated into Alpha Zeta, she was able to share in his excitement, for they had spent long hours together remembering their happy times at Penn State, and especially at Alpha Zeta.

During the reception, John Stinavage presented Cairns with a pledge paddle created especially for him by the Morrill Chapter representatives. On the paddle was listed his full name, major and year he would have graduated from Penn State. It is identical to the pledge paddles created by those who seek to join AZ today.

Following Virginia Chapter tradition, Cairns signed the membership book for Virginia Chapter, with his name, major and "graduation year."

At the conclusion of the reception, Mike Flinchbaugh thanked the Virginia Chapter members for their hospitality and willingness to be involved in the night's festivities. Without them, the evening would have not been possible. On behalf of the Morrill Chapter, he presented chancellor Rusoff with a commemorative paddle, made by the representatives from Penn State, in remembrance of the cooperative spirit each chapter had displayed.

For the undergraduates and alumni members who went to Blacksburg, it was a rewarding time.

The events of that evening are still vivid in my mind. To anyone who was there, it was a moving experience. It was touching to see someone whose life has been filled with numerous accomplishments and rewarding experiences speak so eloquently about how much Alpha Zeta has meant to him over the years. Throughout his career, Dr. Cairns chose to remain true to the legacy he had known for only a few short years. I can only hope that all of us can take meaning from our AZ experiences, and let those experiences remain as much an influence in our lives as they were in his.

Jess Worobey came away from the trip with, she said, "undoubtedly a great appreciation for the chapter that has been established in Pennsylvania, and a sense of duty to keep Alpha Zeta thriving in State College. One reason our fraternity is strong is we have a home, and it is truly a home to all members, past and present. The house spawns a type of fellowship that our colleagues in Virginia only dream about. In many ways, this has been a history lesson for both Virginia and us, a lesson that should have been taught a long time ago. I think there's something to be said about bringing chapters together like this."

To Dr. Cairns, on behalf of all Alpha Zetans around the world, welcome to our family. Your dedication to the fraternity is an inspiration to us all.

Malcolm Andre '63, Helps Bring General Eisenhower to Alpha Zeta for Initiation as Honorary Member in 1963

Alpha Zeta Fraternity, was influential in planning and executing one of the high points in Alpha Zeta history. Thirtynine years ago this May, the Alpha Zeta Chapter at The Pennsylvania State University initiated former

President Dwight D.

Eisenhower as an honorary member. This campaign to

honor Eisenhower began with the efforts of Malcolm Andre and George Shook '63, Censor. Soon everyone in the Fraternity was pitching in with great gusto. Thanks to Herman R. Purdy, Associate Professor of Animal Husbandry and personal friend of the General's, they were able to bring the former president to Penn State for the day and keep his visit fairly quiet.

Alpha Zeta wanted to honor Eisenhower's commitment to agriculture. Andre explained, "We have a Fraternity custom of recognizing outstanding men connected with the development of American agriculture. We couldn't think of anyone more appropriate for this honor than Eisenhower." However, the privilege of initiating an honorary member is rarely extended to a local Fraternity Chapter. In this case, the local Chapter was granted the privilege in commemoration of the Land Grant Act Centennial.

Eisenhower, known as the gentleman farmer, visited the Penn State campus in University Park, Pennsylvania, in 1963 to be initiated into Alpha Zeta and to inspect Penn State's herd of Black Angus cattle. While at Penn State, the former president participated in an informal buffet preceding the initiation. Eisenhower was quoted as saying with a chuckle, "This is the first secret society I've belonged to in my 72 years." The fraternity brothers were impressed by the former President's ready knowledge of cattle and by his friendliness. Andre admits it was one of the highlights of his life.


Not only was Andre Chancellor of Alphas Zeta during his college years, he also was President of The Penn State Blue Band. After Andre graduated in Agronomy in 1963, he spent two years in the U.S. Army and returned to his hometown of Montrose, Pennsylvania, in 1965. There, he joined the family business, Andre & Son, Inc. As the third generation owner, Andre heads up his Farm Material and Services Business with his wife, Kathy, and two sons. He is proud grandfather to four grandchildren.
